RIGHTS & OBLIGATIONS OF A MEMBER

1. Annual Subscription [Article 15]

Annual Subscription: The Executive Committee shall provide for regulations in the Bylaws for Annual Subscriptions.

2. Rights of Members [Article 16]

Both Constituent and Affiliate Members shall be entitled to the following rights:

- ✓ To be respected and treated equally;
- ✓ To give an opinion about the development of the Mandal;
- ✓ To benefit from all privileges available in the Mandal;
- ✓ To participate in the development of the Mandal;
- Right for the Chairperson and Secretary of the Member to participate as Honorary Councilors of Assembly of Councilors and nominate names of Trustees for election by the Assembly of Councilors; and
- Right to further appoint three [3] Hindu Ordinary Councilors to the Assembly of Councilors representing the Social, Medical and Education welfare programs of the Member.
- ✓ Specific rights of the Constituent Members.
- ✓ To elect Office Bearers of the Executive Committee and Trustees;
- ✓ To be elected as members of the Executive Committee and Trustees; and
- ✓ Right of Honorary Councilors of the Members to nominate names of Office Bearers of the Executive Committee for election by the Assembly of Councilors.

3. Obligation of the Members [Article 17]

Constituent and Affiliate Members shall have the following obligations:

- ✓ Duty to treat all the Members equally;
- ✓ Duty to abide by the norms of the Hindu Culture, Religion and Tradition; and
- ✓ Duty to abide by this Constitution and the By-laws.
